Shipped Semen Protocol

The key to breeding your mare with transported cooled semen is very careful planning, management and coordination with your veterinarian and the Breeding Manager.

The first day of breeding season at Fritz Leeman Farm will be Monday February 5th, 2024 and will conclude on Friday June 14th, 2024.

Schedule: MONDAY, WEDNESDAY, FRIDAY starting on February 5th

IMPORTANT- BEFORE THE FIRST SHIPMENT

- **Full breeding fee must be paid before ordering semen**
- **Fully executed contract must be on file prior to ordering semen**
- **Pre-pay each shipment. ON-SITE PICKUPS ARE \$200.00, FEDERAL EXPRESS SHIPMENTS ARE \$350.00, AIRPORT SHIPMENTS ARE \$450.00. Canadian Shipments (FedEx ONLY) for cooled is \$650. We do accept VISA, MASTERCARD, DISCOVER, and AMERICAN EXPRESS. NO SEMEN WILL BE SHIPPED UNLESS PAID FOR IN ADVANCE.**
- We use Federal Express for overnight shipping
 1. Federal Express does not pick up on Saturday or Sunday
 2. Know whether you can receive deliveries on Saturdays
- If counter to counter air service is needed we ship from CLE airport. **Shipments are only sent to MAJOR airports that have Cargo.** Mare Owner is responsible for organizing picking up of shipment upon arrival at destination airport.
- **Shipping information to have available when you place an order:**
 1. Stallion name, mares REGISTERED NAME (NOT NICKNAME)
 2. Good contact name and phone number to receive airline information
 3. Physical address to receive shipment, telephone number, and email address for FedEx notification

SEMEN ORDERS AND SHIPMENTS

- **DO NOT place orders on Facebook or via email. YOU MUST Call 330.418.8380 and speak to a person to request shipments**
- Availability of semen on any given day is **NOT GUARANTEED**
- **ONE** dose of semen will be sent in each shipment
- The priority for semen will be as follows:
 1. Ranch mares
 2. Transit mares
 3. Shipped semen mares. Of the shipped semen mares, all mares that are not foal heat mares will have priority over foal heat mares. The Breeding Manager will prioritize all mares
- **IMPORTANT-** Requests for shipped semen **MUST** be made by **5pm Eastern Time the day before collection.** Any late orders will be charged a \$50 late fee if filled. Confirmation/cancellation of a semen order **must** be made by **8am Eastern time the day of collection.** **Late cancellations will incur a \$50 cancellation fee.**
- PLEASE NOTE: The shipping box must be returned to FRITZ LEEMAN FARM within 5 days of receipt of semen or a \$50 container fee will be charged to credit card on file.
- Use an experienced competent mare management facility. Mares should be on a regular teasing and palpation/ultrasound examination schedule. We request that you palpate mares to determine if they have ovulated in a timely manner or if you need more semen.
- **Confirmation of pregnancy by ultrasound starting at 14 days post ovulation following thru to 45 days of pregnancy is required to maintain the live foal guarantee. Failure to provide pregnancy status will result in mare not being included on the breeding report.**
